## **Minor Amendment to Permit Application Form**

### **INSTRUCTIONS**

1. Print legibly.
2. All blanks must be filled. If the information is not applicable, enter "N/A".

### **IMPORTANT NOTES**

1. Any amendment not defined as a Minor Amendment by CCGCD District Rules is considered to be a Major Amendment and shall be subject to all the requirements and procedures applicable to issuance of a new permit for a new well.
2. No application fee is required for an application for a minor amendment.
3. A minor amendment to a permit may be granted by the General Manager without notice, hearing or further action by the Board. A permittee may apply for a minor amendment for the following actions: (i) change in the name or address of the well owner without change in use; (ii) decrease in the maximum authorized withdrawal; (iii) conversion of two or more wells individually permitted by the same permittee into an aggregate system; or (iv) the addition of domestic or livestock use as a use to a permitted well without the maximum authorized withdrawal amount or rate being increased.
4. The applicant is responsible for ensuring that the Rules of the CCGCD will be followed. Lack of knowledge of the Rules is not a defense of violation of the Rules.
